

2026 British Kart Championships – Standard Supplementary Regulations incorporating the National Competition Rules of Motorsport UK as published from time to time.

1. Cumbria Kart Racing Club will organise a **National** Kart Race on 24th – 26th July 2026 at Cumbria Kart Racing Club, Rowrah, Frizington, CA26 3XU, which is a Championship Event for the 2026 KZ2 & IAME (Water Swift, Junior X30 & Senior X30) British Kart Championship. And an **Interclub** Kart Race on 24th – 26th July 2026 at Cumbria Kart Racing Club, Rowrah, Frizington, CA26 3XU, which is a Championship Event for the 2026 IAME (Water Swift Restricted) British Kart Championship. And a **Clubman (Bambino)** Kart Race on 24th – 26th July 2026 at Cumbria Kart Racing Club, Rowrah, Frizington, CA26 3XU, which is a Championship Event for the 2026 IAME (M1 Bambino) British Kart Championship.
2. This meeting will be organised and administered by Cumbria Kart Racing Club and will be held under the National Competition Rules of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA) and these Supplementary Regulations and any Final Instructions.
3. Motorsport UK has issued Permit Number **TBC** for this Event. The Event is open to other ASN Licence holders.
4. The circuit has been issued for the purposes of Motorsport UK Regulated and insured motorsport events Track Licence Number K/2026_156_01 for Direct Drive and K/2026_172_01 for Gearbox. The track has a Direct Drive track length of 1030 meters and Gearbox track length of 1030 meters. The number of corners is 10 for Direct Drive and 9 for Gearbox and the surface is tarmac.
5. The Event is open to all Competitors registered for the 2026 IAME & KZ2 British Kart Championship.
 - 5.1. All Entrants and Competitor/Entrants must produce the following at documentation (signing-on) for the meeting:
 - a) a valid membership card of a Motorsport UK registered Kart Club;
 - b) a valid Motorsport UK Entrant licence; and/or
 - c) in the case of Competitors under the age of 18 years a valid PG Entrants licence (NCR Ch 18 App 7 Art 5.7);
 - i. in the event that the parent/legal guardian is unable to attend the meeting they must appoint a representative to act, in all respects, on their behalf. The parent/legal guardian retains full responsibility for the actions of their representative as if they themselves were present.
 - ii. the representative must be in possession of the valid PG Entrants licence together with a letter from the PG Entrant licence holder confirming their appointment and consent; and
 - iii. by countersigning as parent/legal guardian/guarantor of a minor you agree that they have no objection to still or moving images being taken of the Competitor undertaking their sporting activities and in connection with the Championship pursuant to the Championship Regulations.

- d) a valid Motorsport UK Kart National Licence as a minimum for KZ2 & IAME Water Swift, Junior X30 & Senior X30, or a valid Motorsport UK Kart Interclub Licence as a minimum for Water Swift Restricted, and a valid Motorsport UK Kart Interclub (Bambino) as a minimum for M1 Bambino, or be in possession of a valid CIK-FIA International Licence, together with their ASNs written consent (NCR Ch 6 App 3 Art 1.6 and FIA ISC Article 2.3.7 (a, b & c) applies);
 - e) In respect of any Competitor hosted by a Team as per 1.3.6 of the Championship Regulations the Team shall for all material purposes under these Regulations be considered to be treated as an Entrant of the Competitor and therefore must at all material times be in possession of the PG licence holders signed authority.
6. This meeting constitutes a Round(s) of the 2026 IAME & KZ2 British Kart Championships;
- 6.1. the timetable for the weekend will be announced in any Event Documentation issued directly to all registered Competitors prior to the Event via email.
 - 6.2. Signing-on and Scrutineering times will be included in the Event Documentation:
 - a) it is imperative that Competitors adhere to the times allocated to avoid undue delays. If any Competitor fails to sign-on or complete scrutineering in the allotted time they may be reported to the Race Director and/or Event Stewards who may impose a penalty that may include Missing a Free Practice, Qualifying Practice or Race.
 - b) if it is anticipated that you will be unable to make the allotted times for exceptional and valid reasons then please advise the Championship Co-ordinator who, following liaison with the Race Director, may make alternative arrangements. If this is not possible 6.2a) above applies.

7. Meeting Format

KZ2 – Single Header

Friday – Free Practice

Saturday – Free Practice/Non-Qualifying Practice, Qualifying Practice, Heats,

Sunday – Heats [if any remaining], Pre-Final & Final

Double Header – IAME

Friday - Free Practice

Saturday & Sunday – Warm Up [if applicable], Qualifying Practice, Heats, Repechage (if applicable) & Final

7.1. Grid positions will be determined by Qualifying Practice as prescribed in the 2026 IAME & KZ2 British Kart Championship Regulations.

7.2. The maximum grid for Direct Drive [Water Swift Restricted, Water Swift, Junior X30 & Senior X30] is 36, 30 for Gearbox and 22 for M1 Bambino.

8. Judges of Fact

The nominated Officials are Judges of Fact in respect of the following and will be confirmed by name in the Final Instructions and/or Event Bulletin:

- a) For vehicle eligibility (2 of): the Chief Scrutineer, Eligibility Scrutineer & Technical Commissioner;
- b) For noise readings: the Environmental Scrutineer;

- c) For number of laps completed: the Timekeepers;
- d) For first across the finish line: the Timekeepers;
- e) For race starts: the Starter and Assistant Starter;
- f) For track limits: all Clerks and observers who may at their discretion use any camera facilities officially at their disposal.
- g) For front fairing infringements:

9. Awards

Trophies will be presented per Round, per class to the highest 3 Competitors classified plus the Winning Competitors' Mechanic/Performance Coach. A Pole Position award will also be issued to the Pole Sitter in each Championship Class.

10. Entries

10.1 The entry fee is £410 for IAME Water Swift, Junior X30 & Senior X30 Competitors, £320 for Water Swift Restricted & M1 Bambino Competitors. These Fees are for the 3-day Event, which includes Friday practice.

The entry fee is £250 per KZ2 Competitor for the 2-day Event. The Optional Friday Free Practice fee is £100 for all KZ2 Competitors.

Any late entries in any Class may incur a £90 fine.

10.2 Entries must be submitted through the online entry system via the British Kart Championship Website

- a) entries must be accompanied with the correct fee;
- b) it is the Competitor's responsibility to ensure the entry is submitted on time and all required details are completed. Entry to the event may be refused if details are not complete and/or the fee not received;
- c) for any queries with entries, please email the Championship Co-ordinator louise.brown@motorsportuk.org;
- d) entries for the event open 6 weeks prior to the event, where possible, and close at noon, 9 days prior to the event;
- e) the minimum entry for each Class is 16 or at the Championship Organiser's discretion.

Please refer to the Championship Regulations, Section 3 for more information.

11. Officials:

The listed officials will be present.

11.1. The Championship Organisers and the Organising Club reserve the right to change Officials when necessary, a list of Officials will be published in the Final Instructions and/or via Event Bulletin:

12. Provisional Results & Results:

- 12.1 provisional results will be published as soon as possible after each Qualifying Practice/Heat/Super Heat and Final(s);
 - 12.2 they will be posted on the Official Notice Board located on www.motorsport-timing.co.uk. It is the Competitors responsibility to check the results once posted; and
 - 12.3 Results published during the weekend will also be online www.motorsport-timing.co.uk
13. Judicial:
- 13.1. Protests must be made in accordance with the National Competition Rules.
 - 13.2. All Judicial procedures will be conducted in conformity with the applicable National Competition Rules.
 - 13.3. The Championship Organisers will be using CCTV/live streaming/cameras at this Event. The footage may be used by the Championship Organisers for judicial purposes.
14. Technical
- 14.1 All karts must comply with the 2026 Motorsport UK NCR & the published 2026 IAME & KZ2 British Kart Championship Regulations (any reference to CIK regulations refers to the CIK 2026 Annuaire);
 - 14.2 Competitors will be identified by their number plate and must use the number assigned following registration, as per the Championship Regulations;
 - 14.3 Tyre Regulations are as detailed in Championship Regulations 4.5; it is the competitors' responsibility to order their Race tyres by the closing of entries for that meeting. All other tyres can be purchased on Event or ordered via British Kart Championships.
 - 14.4 The scales and check weights provided for Competitors' use are deemed to be correct on the day;
 - 14.5 Noise is a particular concern at most venues and noise readings may be taken during the Event:
 - a) any kart exceeding the class noise limit, please also refer to any Club specific rules on noise limits, will be shown the mechanical flag and must leave the circuit directly into and remain in parc ferme until permitted to leave by the Chief Scrutineer who may delegate this function to another official of the Event;
 - 14.6 Control Fuel only is in operation in accordance with the Championship Regulations. It is the competitors' responsibility to order their fuel by the closing of entries for that Event.
15. Race start/stoppage will be as per the 2026 British Kart Championship Regulations applicable to the relevant class.
16. Venue Access & Parking Instructions
- (i) Circuit access is permitted only from 09.00am on the Thursday immediately prior to the meeting.
 - (ii) Paddock/Pit areas will be assigned by Cumbria Kart Racing Club, competitors should contact the venue for more details. It is important that you park within your allocated

area in the Paddock. If you don't you may be required to move, and which will be treated as the instruction of an official of the meeting.

- (iii) It is not permitted to mark off areas.
- (iv) Should you wish to leave your awning on-site from a previous meeting, in preparation of the forthcoming Championship Meeting then you will need to submit your request in writing in advance to the Championship Co-ordinator. The request will be considered by the Championship Organisers and only upon written confirmation are you permitted to do so, and this will be at your own risk and is not insured by Motorsport UK. Without the necessary agreement you will be required to move at the request of the Championship Organiser. Anyone leaving equipment is a contract between the club and competitor/team.
- (v) Under no circumstances is the pegging down of awnings or breaking of the paddock surface permitted. If this occurs, you shall be liable for the cost of all repairs.
- (vi) Competitors and Teams must ensure all trailing cables are certified (current PAT test or similar) as safe to handle and are suitably covered with cable protection mats or other suitable means to ensure there are no tripping hazards.
- (vii) Cars will be prohibited in the paddock, and should you need to drop-off items you will be required to leave your contact details with the Paddock Official. You will be required to then remove your vehicle to an assigned parking area, and should any person refuse the Officials request this will be reported to the Event Stewards and which will be treated as the instruction of an official of the meeting.
- (viii) All cars and vehicles used for overnight accommodation will be parked in a separate area.

17. Health & Safety

17.1 At all times whilst in the confines of the venue Competitors should comply with the circuit Health & Safety guidance notes available on the Club Official Notice Board. Please also refer to the Kart Paddock Safety document available on the Motorsport UK Website.

17.2 Smoking or vaping/electronic cigarettes on the Pre-Grid, circuit or Parc Ferme is prohibited.

17.3 Competitors & Teams are responsible for removal of all waste from their paddock area including but not limited to tyres & fuel drums/cans. Domestic rubbish must be placed in the correct bins provided. Tyres identified to an Entrant and removed by the Organisers shall be subject of an environmental charge for disposal and which must be paid prior to the next Event entered and or on demand of Motorsport UK.

17.4 Stepladders or temporary structures used for viewing adjacent to the circuit perimeter are prohibited.

18. General

18.1 Parking of cars, caravans and motorhomes is not permitted in the paddock area and must be in the designated car parking area.

18.2 Only drivers holding a full RTA licence and who are insured for the vehicle are permitted to drive within the confines of the facility. You may be required to produce evidence of ownership and RTA licence by any official of the meeting or designated person. Failure to produce on request will be treated as a breach of the General Regulations.

- 18.3 The running of engines is NOT permitted between the hours of 18:00-08:00.
 - 18.4 All generators must be switched off by 10pm and not switched on again until 7am.
 - 18.5 Children must always be supervised by an adult at all times whilst in the venue confines.
 - 18.6 Paddock speed limit is 5mph.
 - 18.7 All access lanes in the paddock area must always be kept clear in case of the need for emergency vehicle access. Any electric cables across the walkways must be covered at all times.
 - 18.8 Any Competitor, or persons, connected with a Competitor found to have caused damage to any property or the surrounding areas, or on the venue, may be banned from the venue and/or be disqualified from the Championship. This also applies to anyone trespassing on surrounding areas. Please note, the quarry banks and pond at the top of the circuit are prohibited and strictly out of bounds.
 - 18.9 Dogs are permitted at the venue for the duration of the event but must be kept on leads at all times. Dogs are to be kept in your pit bay area and exercised outside of the venue. The walking of dogs around the circuit is NOT permitted.
 - 18.9.1 Any person responsible for their uncollected dog fouling will be instructed to leave the circuit confines and will not be permitted to return.
 - 18.10 All Championship and/or club Officials instructions must be adhered to at all times, this includes parking up of your vehicle(s) and awnings.
 - 18.11 Fire extinguishers provided by teams and competitors are mandatory as per Motorsport UK Karting Yearbook Appendix 5 B.12
 - 18.12 No pit bikes, push bikes, skates or skateboards, scooters, mopeds, hoverboards, Segways, Remote Control cars/trucks or ball games are permitted within the confines of the track and surrounding enclosures during track activity nor on the approach road to the circuit at any time;
 - 18.12.1 Motorised or electric scooters, boards or mopeds are not permitted at any time, unless proven to have valid insurance and written authority from the Championship Organisers.
 - 18.13 Noise measurements will be as per NCR Ch 18 App 8 Art 13 in accordance with the point detailed on the track licence. Any kart that has a loss of, a breakage or excessive leakage in the exhaust system must immediately stop racing and park in a place of safety and not attempt to return to the pits.
19. Motorsport UK Regulations policies and procedures in respect of safeguarding, behavior generally, social media, alcohol and illicit drugs apply throughout the Event venue and are applicable to all persons present howsoever connected to an Entry at or to do with the event. Any and all breaches of the applicable Regulations and policies will result in disciplinary action being taken and may lead to removal from the venue / Event.
20. Any person who has a concern regarding safeguarding at any time at the Event / venue should immediately report the matter to the Safeguarding Officer and or the Secretary of the Meeting. The Event Secretary can be reached on louise.brown@motorsportuk.org.
21. Any complaints regarding behavior generally, social media, alcohol or illicit drugs should in the first instance refer the matters to the Secretary of the Meeting or the Championship Coordinator.

22. Club Specific Provisions

22.1 The quarry banks and pond at the top of the circuit are prohibited and are strictly out of bounds.

22.2 No metal sprocket protectors are allowed at Rowrah – plastic only.
